## SOLDIER FIELD SWEEPSTAKES - OFFICIAL RULES

**Eligibility**: The Soldier Field Sweepstakes (the "Sweepstakes") is open to individuals who are at least 18 years of age. Entrants are subject to all applicable federal, state and local laws and regulations. Void where prohibited by law.

**Sponsor**: The Sweepstakes is sponsored by SMG, d/b/a Soldier Field, 1410 S. Special Olympics Drive, Chicago, Illinois 60605 (the "Sponsor").
